**Call to Order** – 2:06 PM

- Welcome and Introduction of our new members
  - Martha Opoien, Susan Gibson, Lisa Patton, and Jeanette Kragel were introduced. New members unable to attend are Terri Betlewski, Darcie Trimmer, Nancy Hatten, Erika Aguirre, Sandy Briggs, and Tammy Ricksecker
  - Update from the summer – Laura again thanked the league for their generous support following the death of Sharon's daughter
  - The Board will be setting the schedule for 2026 at their Dec 2 board meeting

**Approval of March 4, 2025 Minutes**

- Minutes were emailed out to members prior to the meeting,
- Linda Walker moved to accept the minutes as presented. Cindy Olson seconded. The minutes were approved.

**Treasurer's Report – Chris Thompson**

- Chirs did not have a formal report to present. This time of the year our funds are in a flux. We have approximately \$5500 in the treasury including roughly \$2500 in players funds.
- Chris passed around copies of current members accounts so members could see their current balances

**Membership Report --- Edie Copley and Chris Thompson**

- Edie and Chirs have been working closely together on Membership. Membership forms were available at the meeting. Completed forms with payment should go to Chris Thompson. There is no longer a league desk in the pro shop.
- The funds need to be paid by December 15. This will allow the league time to identify people who have dropped league membership so we can avoid paying AGA and SDWGA for those people.
- Membership fees can be paid one of four ways – check, Zelle, cash, or from your membership account.
- If every current member re-ups, we will have 53 members.

**AGA – Shirley Hill (Medallion)**

- The state medallion tournament requires qualifying rounds. The lowest net and lowest gross scorers from the qualifying rounds will be invited to go to state. Our league has four Medallion qualifying rounds (January, April, summer, November). You must play in at least two of the qualifying rounds to be eligible to go to state. Our league plays the representative's registration fees. The players are responsible for their own lodging, food, and transportation. Qualifying starts in January.
- Our representatives at the tournament this year will be Laura Fisher (low net) and Kathleen Austin (low gross),

**GHIN – Julie Gish**

- AGA has changed how they charge for GHIN. Formerly your GHIN membership was from January 1 to December 31. Now you can start your GHIN any day of the year and it will expire one year later. This change will not affect the vast majority of our league as we are on the January thru December schedule already.

- You should post every round you play unless you are playing by yourself, playing two balls, or something along those lines.
- If you accidentally post an incorrect score, contact Julie and she can get it corrected in GHIN.

### **SDWGA – Sandy Cooney**

- Southern District membership is an optional supplement to SILGA membership. It is an additional \$10.
  - \$5 of this fee goes to SDWGA
  - The other \$5 remains with the league for the two intra-league SDWGA tournaments\
    - SD Eclectic – Del Sud and SD Telegraph – a two-day ringer tournament
    - SD Telegraph – a flighted low net tournament
- The next SDWGA tournament is the Winter Scotch – Feb 23. It is a Partner tournament
- Tournament registration is tight – there is a two-week window where registrations are accepted, then a two-week window to determine the players. Currently, if you are waitlisted two tournaments in a row, with the exact same team, you will automatically get into the next tournament if you register for it.

### **Tournament Chair – Shirley Gray and Kathleen Austin**

- Shirley will run the weekly tournaments. Kathleen Austin will run major tournaments (President's Cup, Match Play, and Club Championship).
- The President's Cup will be December 9 and December 16. The Holiday Party will be that day & the winners will be awarded at the party.
- February will be Match Play
- Club Championship will be in March/early April – the dates are not yet set.

### **Closest to the Pin (CtP) – Necile Miller**

- The closest to the pin contest occurs once monthly on the first Tuesday of the month. All four par 3 holes are in play. This is a flighted event – two of the par 3's are for one flight and the remaining two are for the other flight. There is a \$1.00 entry fee to participate in this event.

### **Interclub – Lynn Janis – Reported by Jan Rintala**

- There are six Interclub tournaments:
  - April 2 (Green Valley Country Club), April 27 (Torres Blancas)
  - May 14 (Quail Creek), May 25 (Canoa Ranch)
  - June 9 (San Ignacio), June 24 (Desert Hills)
- To be eligible to play in an Interclub tournament you must have played in a league qualifying round. The lowest four net and lowest four gross in the qualifying round are the league's representatives in the Interclub tournaments. Different people can represent the league in each Interclub tournament.
- If you have an idea for team shirts, please contact Lynne Janis. Currently the league is looking at Amazon for team shirts due to competitive pricing and variations on styles.
- Tina Davita suggested that if you want to represent our league you should commit to playing in at least two of the tournaments. In May and June it can be difficult to find people willing to play. No motion was made on this suggestion.

### **City League and Kachina Dolls– Jan Rintala**

- City League
  - If you are a member of City League, then you can sign up as an individual for their events. Events are held on the second Monday of each month.
  - The event schedule is 1/12 (Oro Valley), 2/9 (AZ National), 3/9 (Tucson National Golf Resort), and 4/13 (Fun Day – TBD).
  - Stableford scoring is used. Low gross and low net prizes are awarded.
  - Membership is currently closed, but you can submit a membership to be on the waiting list. Applications for membership begin the day following the Fun Day tournament.
